Maine State Junior Gold Rules 2014-2015

- 1. This tournament is certified by the United States Bowling Congress and shall be governed by USBC. A minimum of 6 Junior Gold members participating will be required to be considered a Junior Gold qualifier.
- 2. Tournaments will start at 3 PM, except the last May 2 is at 2 PM.

- 3. Qualifiers are based on a 1:6 ratio and a major fraction thereof. Divisions are combined for competition, for qualifying in our state. For Points for our award system (See rule 13.), we have U20 and U15 divisions. Any bowler with a birth date of 8/1/99 or later will participate in the U15 division. All others will participate in U20 division. Bowlers must have a Standard and Junior Gold membership before participating in the tournament. Junior Gold membership fee is \$30.
- 4. The tournament format shall be Scratch, 5 games, total score bowled on a challenging oil pattern, sport pattern if possible.
- 5. Entry fee is \$30.00 per tournament.

- 6. All bowlers must wear suitable attire. Bowler must wear a collared shirt or league sponsored t-shirt. Mid-thigh length or longer shorts are acceptable. Bowler may not wear a hat/cap, "co-ed naked" anything, shirts not covering midriff, pants with holes, sweat pants, short shorts, and skin tight or spandex clothing. Bowlers deemed in violation will not be allowed to compete until corrected. Final determination will rest with the tournament director. There will be no alcoholic beverages on the concourse while competition is in progress.
- 7. Only bowlers and tournament officials shall be permitted in the settee area.
- 8. Ties will be broken by a 9th and 10th frame roll-off. Should a tie still exist, it will be broken by an additional 9th and 10th frame roll-off.
- 9. Claims for errors in scoring or general playing rules must be made to the tournament director no later than the end of the tournament. The tournament director shall decide upon questionable errors, and his/her decision will be final.
- 10. Failure to abide by any rules and regulations will lead to disqualification from this event.
- 11. You must inform the tournament director at least 8 weeks (by 5/16/15) prior to the tournament date of July 11, 2015, if you are unable to attend the national tournament in Chicago, IL, so that a replacement can be made. If the first place winner is unable to attend or declines the spot, the next player in line will have the option to take the spot.
- 12. All bowlers MUST follow USBC rule 400, regarding youth membership eligibility.

13. After all administration expenses are paid, the top two points winners in the U20 division and the top points winner in the U15 division at the end of the season will be awarded money for travel expenses. Awards will be 30% of remaining money (or up to \$500) for 1st place in U20, 25% (or up to \$400) for 2nd, and 25% (or up to \$400) for 1st place in U15. Remaining money from fundraising will be divided up evenly among the qualifiers. All expense money is to be given after the bowlers have attended the National tournament. Points are as follows for each division:

25 points for winning division

20 points for 2nd place 15 points for 3rd place

10 points for 4th place

1 point less for each place below 4th up to 8th place

5 points each for participation after 8th place

Note:

Rule 3: Per USBC, a major fraction cannot be used until after the initial ratio number has been reached. For qualifying purposes, the divisions are combined.

Rule 13: Division points are allocated separately.
